Mr. Manfre: Resolution No. 28-17 is a Resolution of Upper Darby Township, Delaware County, Pennsylvania, supporting the Administration's application to the Department of Conservation and Natural Resources for a grant to purchase open space that will enhance natural resources and recreational opportunities in Upper Darby Township.

Mr. Bonnett: That was a motion. Is there a second?

Mr. Wagner: Second.

Mr. Gwin: I would just like to ask a question. In terms of where the funds will be coming from to support the purchase here, how we have it and when will we be able to know what's happening. I did discuss it briefly with Tom.

Mayor Micozzie: Did you get your answer?

Mr. Gwin: I got some information.

Mayor Micozzie: In the Capital Budget, as always, there is money that is in there that we can always come to Council and transfer around. I guess the question is the Comprehensive Plan that we are currently under, the Comprehensive Plan that we are working on currently always speaks of purchasing open space to save natural resources, drainage, flooding and issues like that. The current process of that ground is in an RC-1 residential district that the neighbors there enhanced back in 1996. Councilman Bonnett, as well as Lisa, are involved in discussions with the property owner. In that RC-1 residential conservation district, it specifically spells out that that area's special residential conservations district that we would provide that the special needs of environmentally sensitive areas of the Township, encourage the conservation of areas where limitations exist, of the development by reasons of slope, unfavorable soil conditions, topography, facilitation-----that that area has had in the past. I guess the question that we would have to present is, the grant application is, I believe, \$200,000.00 Tom?

Mr. Judge: It is \$340,000.00.

Mayor Micozzie: If it doesn't come through, we would have to find other resources to do it. We've had great success in the County and the Township with natural resources. I guess the question is if we're not going to pursue these items and have the opportunity to switch budgets around then, we shouldn't identify in the Comprehensive Plan. Right now there's 7 properties, Drexeline, Pilgrim Gardens, Drexel Park lots, the corner of Edmonds and Garrett, the corner of Lansdowne and State all listed as properties that were identified in the Comprehensive Plan that if they become available we are to, and this property obviously, there's two properties out there, one is this. If they come up, I guess we have to figure out ways of not putting it in the Comprehensive Plan if we're not going to support it because the Comprehensive Plan supports the budget.

Mr. Gwin: What I was trying to find out is what source in the budget is going to be used to fund.....

Mr. Bonnett: Bob, you said you spoke with Tom Judge and you did get an answer on that?

Mr. Gwin: What he said, I'll let Tom speak for himself on that.

Mr. Judge: Currently, we do not have the money identified and targeted for this. If the grant comes through and we are available to move forward with this, we have money in the Capital Budget which would be moved around and we would delay some projects and move this forward at that time. That's a natural progression of doing business. You put money in for a project and "a" comes ahead faster than "b" so you move "a" up and move "b" back.

Mr. Bonnett: Correct me if I'm wrong but if we're purchasing land, it must be by Ordinance?

Mr. Judge: We would need an Ordinance to purchase this land. This is a Resolution asking Council to support our application for a grant. We requested \$340,500.00 for the grant application. If this grant fails, we will scramble to try to work it out because we will be short that amount of money and we'll have to figure something out.

Mr. Bonnett: Any other questions?

Mrs. Faraglia: No but it would save the church and the parish too. If it works out, everybody benefits.

Mr. Judge: That's not our reason. Our reasoning is open space.

Mrs. Faraglia: I know but...

Mr. Judge: I understand but the reason that Council has considered this is that this is the purchase of open space and will they support the grant application? We're not asking to support the purchase. That comes on another day at another time. This is just supporting the grant application.

Mr. Wagner: It should be noted that we've had a lot of expressions of public support for the idea of maintaining open space, correct?

Mr. Bonnett: Correct. Unless there are any other comments, it has been moved and seconded. All those in favor signify by saying aye. Opposed? The ayes have it. The next Committee is Municipal Services, Licensing & Public Works Committee, Councilman Bierling please.

Anyone wishing to speak on this Ordinance, please come forward to the podium and state your name and address for the record. Seeing no one, I will close the Public Hearing and turn the meeting back over to Councilman Wagner.

Mr. Wagner: Very good. Thank you, Mr. President. I understand that Councilwoman Coles has a question before we move forward.

Ms. Coles: I just wanted to know if there was any concern or feedback from the School District, the Administration or School Board about this. I assume this was brought up because of the school buses idling too long in certain spots in Councilman Manfre's district.

Mr. Manfre: I did have some discussion with them and there is concern but there is a safety issue and it is a severe safety issue and we're handling it with this Ordinance. I haven't heard much feedback in the last two weeks.

Ms. Coles: OK. I was just curious because I know that the parking lot for the school buses is right there near where the streets are listed in the Ordinance. It's right near the Bond Shopping Center.

Mr. Manfre: Right, State and Lansdowne.

Mayor Micozzie: This is on Cedar.

Ms. Coles: They park right there where the baseball field.....

Mr. Manfre: Right, Golf Field at Golf Road.

Mayor Micozzie: Marc and I had a conversation and from the Administration's standpoint and the Police Department, buses are to be used on state highways. Cedar Lane, although it acts like a state highway, is not a state highway. It has multiple stop signs. We had conversations on cost and what happens with this, that and the other thing but the truth of the matter is that Marc reached out and

Mr. Manfre: They are using it as a thru-way.

Ms. Coles: So, they understand and they have a plan and they're not going to be parking there so they won't incur any fines.

Mr. Manfre: It's not an issue of parking. They are accessing Cedar Lane to get to their depot which is Golf Field where the Sanitation Yard is. There is no stop there. In my opinion, it has been haphazard and the residents are tired of it and we acted on it. It's nothing to do with parking, it's more of them using it as a thru-way as a cut-thru to get to the Golf Road Depot.

Mayor Micozzie: We've asked them for their routes and if there is a drop-off point off of Cedar and they have to pick a child up to get to Highland Park, this Ordinance does not apply to them.

Ms. Coles: So, they can still pick up the child?

Mr. Manfre: Yes.

Mayor Micozzie: If anyone has a route stop, and we've asked that, we were going to have a meeting with them but at the end of the day the residents control the streets of Upper Darby.

Ms. Coles: I wasn't sure what the school district had in place to deal with so many buses.

Mr. Bierling: Upper Darby is not the only one through there. You have William Penn coming up and Southeast Delco coming up Lansdowne Avenue and to cut off going up to West Chester Pike to turn around, or Township Line rather. They are cutting through there and they come out over by where the golf course is over there. So, they make that quick jaunt instead of going all the way up and coming around.

Mayor Micozzie: School Lane had the same issue years ago because instead of going all the way out to Garrett, they cut down School Lane. That is how this Ordinance originated back in the 90's.

Ms. Coles: Thank you.

Mr. Wagner: OK. Any further discussion at all? With that, I would move for the adoption of Ordinance No. 3039.

Mr. Gwin: Second.

Mr. Bonnett: Moved and seconded. All those in favor signify by saying aye. Opposed? The ayes have it. Mr. Secretary, please take a roll call vote.

Solicitor: Ordinance No. 3040 is an Ordinance of the Township of Upper Darby, Delaware County, Pennsylvania, pursuant to Article VI of the Pennsylvania Municipalities Planning Code, amending the Upper Darby Township Zoning Ordinance by regulating medical marijuana dispensary facilities as special exceptions in the C-3 Zoning District and further regulating medical marijuana dispensaries and medical marijuana grower/processor facilities as a permitted principle use in the C-4 Zoning District. This will amend Ordinance No. 3038 which was adopted at the April 19th Council Meeting. Ordinance No. 3040 does is to slightly amend what Council approved on April 19th by deleting the restriction that marijuana grower/processor facilities cannot be within 1000 feet of a property line of an institutional zoning district. The

Committee reviewed it further after the April 19th Council Meeting and is going to delete that restriction.

Mr. Bonnett: This makes this more consistent with state law?

Solicitor: Correct. And it also addresses some of the concerns that we heard in the public comment at the April 19th meeting.

Mr. Bierling: Thank you. I hereby move that the proposed Ordinance No. 3040 be duly advertised and placed on the agenda for the June 21st, 2017 regular Council Meeting.



WHEREAS, the application package includes a document entitled "Terms and Conditions of Grant" and a document entitled "Grant Agreement Signature Page"; and




NOW THEREFORE, it is resolved that:

WHEREAS, the Delaware County 2016 Hazard Mitigation Plan recommends mitigation activities that will reduce losses to life and property affected by both natural and human-made hazards that face the County and its municipal governments;



Ordinance No. 3039

AN ORDINANCE OF THE TOWNSHIP OF UPPER DARBY, DELAWARE COUNTY, PENNSYLVANIA AMENDING ORDINANCE 2799 PROVIDING THAT SCHOOL BUSES AND SCHOOL VEHICLES SHALL BE PROHIBITED FROM OPERATING ON CERTAIN TOWNSHIP HIGHWAYS EXCEPT FOR THE PURPOSE OF PICKING UP AND DISCHARGING PASSENGERS; AND TO PROVIDE FOR PENALTIES FOR THE VIOLATION THEREOF.

BE IT ENACTED AND ORDAINED by the Council of Upper Darby Township, County of Delaware, Commonwealth of Pennsylvania and it is hereby enacted and ordained by the authority of the same:

SECTION 1. Ordinance 2799 section 4 of Upper Darby Township is amended as follows:

The Township is authorized to have the proper official signs stating “No School Buses except for Pick-up and Discharge of Passengers” erected at the following additional locations.


Intersection of Cedar Lane and Lansdowne Avenue
Intersection of Cedar Lane and Park Avenue
Intersection of Cedar Lane and West Chester Pike
Intersection of Park Avenue and West Chester Pike


SECTION 2. Repealer. Any ordinance or part of an ordinance to the extent that it is inconsistent herewith is hereby repealed.

SECTION 3. Severability. The provisions of this Ordinance are severable and if any section, sentence, clause, part, or provision hereof shall be held illegal, invalid, or unconstitutional by any Court of competent jurisdiction, such decision of this court shall not affect or impair the remaining sections, sentences, clauses, parts or provisions of this ordinance. It is hereby declared to be the intent of the Council that this ordinance would have been adopted if such illegal, invalid, or unconstitutional section, sentence, clause, part, or provision had not been included herein.


SECTION 4. Effective Date. This Ordinance shall become effective thirty (30) days following final adoption by the Township Council and publication as required by law.
