Ms. Wentz: I'm just curious why the information wasn't provided earlier, prior to the meeting of these appointments and who was being.....I mean, we got a lot of information but I just don't understand why the appointments weren't on a page for us to know that this was coming instead of all of a sudden this happening and not having any knowledge of it.

Mr. Bonnett: All I can tell you is that we will get it to you.

Mr. Judge: Most of these people are incumbents so they've been on the boards for many, many years.

Mr. Bonnett: They are pretty well known by everyone else.

Mr. Wagner: A former member of this Council.

Mr. Bonnett: A former member of this Council, correct.

Mayor Micozzie: If anyone has anybody, we're always looking for people so send me a resume.

Ms. Wentz: OK, great.

Mr. Bonnett: A motion has been made and seconded. All those in favor signify by saying aye. Opposed? The ayes have it.

Mr. Bonnett: A motion would be in order for the collective names to the Library Board.

Mr. Bonnett: A motion has been made and seconded. All those in favor signify by saying aye. Opposed? The ayes have it.

The re-appointment of Thomas Wagner to the Upper Darby Township Industrial Development Authority for a five-year term expiring 1/1/22

Mr. Bonnett: Is there a motion?

Mr. Wagner: I'll abstain from this.

Mr. Bierling: So moved.

Mr. Spellman: Seconded.

Mr. Bonnett: It's been moved and seconded. All those in favor.....

Ms. Keffer: I have a question. What does the Authority do?

Mr. Judge: I can handle that. The Industrial Development.....

Ms. Keffer: Councilman Wagner is on the Authority now, right?

Mr. Bonnett: He has to be independent to that.

Mr. Wagner: I can answer or Mr. Judge can answer.

Mr. Judge: The Industrial Development Board is a Board that lends money to organizations that want to do market investment in the community or who have an association with the community. It costs the Township nothing. It is a bond-free bank note Board and they vote on issues. I think the last one they did was Latin Boys School in the city of Philadelphia where they used a number of children from Upper Darby that go there to connect it to the Industrial Development Board and they were able to borrow money at a better than market rate from the banks. It costs the Township nothing. It is just an opportunity for them to do that. Adam, is that right? You might want to add a little bit to that.

Mr. Wagner: I'll add 2 caveats to it. Though it is not Township money, it is not public money being lent at all. The money comes from banks. But, if the applicant can satisfy the Board that I sit on, that the project involved is in the best interest of the community then that Board is able to lend its tax advantage stats to the loan and that permits the borrower to borrow the money at better than market rates. I'll add another caveat. The new tax laws that have just gone into effect now will have a bearing on this and Boards of that kind are wondering if they're going to continue to be in business because the tax laws are decreasing the advantage that was previously enjoyed by applicants to these Boards. When I say "these Boards", it is not just Upper Darby that has a Board of this kind. There are numerous ones. I am also a member of the Delaware County Authority which does exactly the same thing at the County level. So, we're all wondering, quite frankly, where that's going in light of the new tax laws. Those laws are being interpreted now by lawyers who are tax lawyers. I'm just a trial lawyer so I'm waiting for their opinions about it. Anyway, does that answer your question?

Ms. Keffer: Thank you.

UNABLE TO HEAR BECAUSE PEOPLE WERE SPEAKING AT THE SAME TIME

Mr. Wagner: And, the Board's purpose is to make a determination that the project in question benefits the community.

Mr. Gwin: It's kind of like angel financing then?

Solicitor: They're what are called conduit issuers. It's not their money. The money either comes from a bank or it comes from bond holders, someone who deals with bonds.

Mr. Wagner: Typically the applicants are educational institutions, universities and high schools who would like to build additional facilities on their campuses or they are assisted living facilities; places like that that have some impact on the community.

Mr. Bonnett: OK. We have a Motion that was moved and seconded. All those in favor signify by saying aye. Opposed? The ayes have it. Congratulations Tom.

Mr. Wagner: Thank you very much. And note that I did abstain.

Mr. Bonnett: Please note Mr. Secretary that there was one abstention. Mr. Mayor, if you have nothing else we will go into the Committee Reports, Planning, Zoning & Building Code Committee, Mr. Bierling please.

Solicitor: Resolution No. 04-18 is a Resolution of Upper Darby Township, Delaware County, Pennsylvania in accordance with Section 603 of the Home Rule Charter that sets the salary of the Township Treasurer.

Mr. Wagner: And despite the fact that I note that this gives the Treasurer a salary that is 50% larger than mine as a Councilperson, I am nonetheless moving for the adoption of Resolution No. 04-18.

Mr. Gwin: Second.

Ms. Wentz: I have a question or I have a point of order. I am just curious. Since Council approved the Budget that included the line item of the salary of \$7500 in December for the 2018 Budget then I would think that the salary part has already been approved by Council because it was part of the line item of the Budget itself.

Mr. Bonnett: No. The point is that we have traditionally.....

Mr. Judge: It's a requirement in the Home Rule Charter....

Mr. Bonnett: It is. It's a requirement that Council adopt this. The point is that this salary has been consistent I think, forever \$7500.

Mr. Wagner: It's in the Home Rule Charter.

Mr. Bonnett: No, it's not.....

Ms. Wentz: Not specifically. But within the budget, it was approved within the Budget already as a line item already so then why would it be in this Resolution?

Mr. Bonnett: There is an absolute requirement that I think is either in the Home Rule Charter of the Administrative Code.

Mr. Judge: It's in the Home Rule Charter that Council must approve it by Resolution.

Ms. Wentz: So, is it every year that there is a new Treasurer, every 4 years that there is a new Treasurer, so this same type of Resolution took place 4 years ago?

Mr. Bonnett: I don't know. I haven't looked at 4 years ago.

Ms. Wentz: Well that would be when the last Treasurer was.....

Mr. Bonnett: He was paid \$7500. I know that for a fact.

Ms. Wentz: Right. So 4 years ago there was a Resolution at that time?

Mr. Bonnett: I can't sit here and tell you that. I don't know that.

Ms. Keffer: It wasn't included in the Minutes.

Mr. Judge: What's the point?

Ms.Keffer: Well...

Mr. Judge: The point is the Home Rule Charter says that you have to have a Resolution where Council has to authorize the salary. When we do the Budget, we are forecasting what we think the salaries are going to be. You approved it but that doesn't mean he's going to get paid that. If you guys said "no, we're going to pay him \$2500", then he wouldn't get paid \$7500. The line item would still be there but he would only be paid a lower amount.

Mr. Manfre: He's going to get OT tonight!

Laughter.

Ms. Wentz: OK. I was just questioning for clarification.

Mr. Bonnett: The point is that we're obligated under the Home Rule Charter.

Mr. Judge: Don't approve it. We won't pay him.

Ms. Wentz: No, I'm approving it but I was just trying to understand.

Mayor Micozzie: Just like as an example, I put all my Department Heads, when I run for Mayor, all of the Department Heads salaries are listed but when I hire someone, it doesn't mean that I'm going to pay someone who is here for 25 years the same amount of money when I negotiate with a new person like the Fire Chief because the number is different. We don't use all the money but the Department Heads have to get appointed when I become Mayor.

Ms. Wentz: OK. I'm just trying to understand the realm. That's all. Thank you.

Ms. Keffer: I just wanted to say because we didn't, at least the Minutes don't show in 2014 that we voted on a similar Resolution. But, that might just be.....

Mr. Judge: I'll try to get the money back from the former Treasurer.

Ms. Keffer: Another thing is, I think it is Section 604 and not 603. I think it's a typo.

Mr. Wagner: Mr. President, I'm moving for the adoption of this Resolution with the correction of this typo.

Mr. Gwin: Second.

Mr. Bonnett: Moved and seconded with the amendment of the Section of the Home Rule Charter 604. All those in favor signify by saying aye. Opposed? The ayes have it.

Mr. Wagner: Mr. President, before I yield the floor, though a number of other people are trying to take it, I am going to follow up with something the Mayor said a minute ago. The Mayor and a number of members of this Council attended a remarkable celebration of the life of Dr. Martin Luther King on Monday night at the Beulah Tabernacle. 

1. Applicant has obtained approval by Pennsylvania Department of Transportation of all necessary permits, including but not limited to any required highway occupancy permit, where applicable.
2. Approval by the Township Solicitor and execution by Batchelor Brothers, Inc. and where applicable, Applicant’s lender, of all necessary and appropriate documentation where applicable including Developer’s Agreement and Improvement Security Agreement, and such other documentation as acceptable to the Solicitor, including but not limited to documentation concerning the ongoing maintenance, operation and repair of the common site improvements, if any, which are not to be dedicated to the Township;

3. Applicant obtaining Sewer Planning Module Act 537 approvals or exemption there from, Storm Water Management approvals and Delaware County Conservation District approvals where applicable;


4. Formal recording of the Land Development Plan (the "Record Plans") following Township execution of the Record Plans;


5. Applicant shall comply with all applicable federal, state and local codes or ordinances and shall obtain all required permits.

WHEREAS, Scott Alberts has been duly elected and sworn to the office of Township Treasurer for the above noted period.


NOW THEREFORE, it is resolved that:






