ORDINANCE NO. 3049

AN ORDINANCE OF UPPER DARBY TOWNSHIP, DELAWARE COUNTY, PENNSYLVANIA, AUTHORIZING THAT PART OF CERTAIN UNENCUMBERED APPROPRIATIONS ALLOCATED BY THE ANNUAL BUDGET FOR UPPER DARBY TOWNSHIP FOR THE YEAR 2018 BE TRANSFERRED FROM VARIOUS DEPARTMENTS, OFFICES AND AGENCIES TO OTHER DEPARTMENTS, OFFICES AND AGENCIES WITHIN THE TOWNSHIP. ALL ORDINANCES AND PARTS OF ORDINANCES INCONSISTENT HERewith ARE HEREBY REPEALED.

WHEREAS, Section 909D of the Upper Darby Township Home Rule Charter provides that Council may by ordinance transfer part or all of any unencumbered appropriation balance from one department, office or agency to another.

WHEREAS, pursuant to Section 909D of the Upper Darby Township Home Rule Charter the Mayor has requested that parts of certain unencumbered appropriations allocated in the Annual Budget of Upper Darby Township for the year 2018 be transferred from the unencumbered fund balance to other departments, offices or agencies within the Township.


NOW THEREFORE, Upper Darby Township hereby ordains:


SECTION 1. Pursuant to the provisions of Section 909D of the Home Rule Charter of Upper Darby Township, Delaware County, Pennsylvania One Million Eight Hundred Thousand ~~(\$1,800,000)~~ [@] of the unencumbered fund balance of the Annual Budget of Upper Darby Township for the year 2018 should be transferred as follows:




WHEREAS, Upper Darby Township plans to submitted a TE-160 application for the above named intersection:

NOW THEREFORE, it is resolved that on behalf of the Upper Darby Township the applications can be signed by the MAYOR, Upper Darby Township.




