A RESOLUTION OF UPPER DARBY TOWNSHIP, DELAWARE COUNTY, PENNSYLVANIA SUPPORTING THE ADMINIISTRATIONS APPLICATION TO THE DEPARTMENT OF COMMUNITY AND ECONOMIC DEVELOPMENT (DCED) FOR A GRANT STRATEGIC MANAGEMENT PLANNING PROGRAM RELATED TO ECONOMIC DEVELOPMENT OPPORTUNITES IN UPPER DARBY TOWNSHIP.

WHEREAS, Upper Darby Township ("Applicant") desires to undertake the following project Economic Development Projects and

WHEREAS, Upper Darby Township wishes to participate in the DCED Strategic Management Planning Program and;

WHEREAS, the Pennsylvania Department of Community and Economic Development make available grants-in -aid via aid through their Strategic Management Planning Program:

NOW THEREFORE, it is resolved that:
