Good evening everyone,

Inderbir Randhawa, Matthew Terry and Adam Wheatley. These officers come from the most qualified and diverse class in Township history, and they will be a great addition to the Department. I am delighted and honored to welcome them into our Upper Darby team. In addition, I would like to acknowledge the Civil Service Commission, which played an important and behind the scenes part, into making this a reality.

We are currently working on several grants for Upper Darby, including a Keystone Facade Grant. We are applying for funding from DCED that we would offer to small businesses for street-facing exterior improvements, such as painting, repointing, facade repair or restoration, and signage. This grant is for \$50,000, with an equal match from the Township. Due to limited funding, we would focus this program on the unit block of Garrett Road, work on the kinks, learn the system and expand the program to our other neighborhood business districts. I have personally visited many of the businesses in the area, and there is a lot of interest in and support for this initiative.

We are also working on a community project-funding request to Congresswoman Mary Gay Scanlon's Office for the new Upper Darby Community Center.

Yesterday, U.S. Secretary of Education Miguel Cardona visited Upper Darby High School and Beverly Hills Middle School as part of the Biden Administration's efforts to support states, schools, students, parents, and educators as they navigate the return to in-person learning. We talked about how the township and the school district have forged a strong working relationship over the past year and a few months to advance the district's capital plans for improvements including the Aronimink Elementary expansion as well as understanding and streamlining our shared services.

We had some more good news this week: after fielding questions from S&P concerning some of the audit findings as well as revenue forecasts in the COVID ERA, I am pleased to announce that the end-effect is that S&P has granted us an A+ stable rating. It was an elongated process and credit goes to CAO Vincent Rongione and Finance Director Gary Merron for their diligent work on this.

The Darby Creek Valley Association's annual cleanup will take place this Saturday, April 10, from 9 am to 12 pm. eleven sites need help in our Township. Please visit <u>dcva.org/watershed-cleanups</u> to register for a specific site. Representative Mike Zabel and I will be site captains, and it is a great way to get involved.

The Upper Darby Environmental Advisory Committee and the Friends of Upper Darby Trails will hold a Learn and Hike event on Saturday, April 24, in honor of Earth Day. There will be three separate hikes throughout the day: one along the Recreation Area Trail beginning at 9 a.m., one at the Underground Railroad Trail Spur beginning at 1 p.m., and one at Naylor's Run Park Trail beginning at 6 p.m. More details can be found on the Environmental Advisory's Facebook page.

Our new weekly yard waste collection service started this week and will continue until Friday, November 19. Yard Waste will be collected weekly on residents' regularly scheduled recycling pick up day. Yard waste is defined as leaves, garden residues, shrubbery and tree trimmings, and similar material. Please note that grass clippings are NOT considered yard waste. Please do not use plastic bags to collect your yard waste. Instead, place it in biodegradable paper bags, which are available at local hardware stores, including Burhill on Burmont Road and the True Value on Marshall Road, as well as Home Depot and Lowes, or place the yard waste loosely in trashcans without bags.

Finally, Upper Darby was selected as one of twenty municipalities in Pennsylvania to participate in the Department of Environmental Protections' 2021 Local Climate Action Program that matches local governments

with college students to develop greenhouse gas inventories and climate action plans. I am pleased to introduce Melissa Morales and Janniry Belen from Moravian College who have been working with us this semester.

Motion to approve Memorandum of Understanding and side letter between Upper Darby Township and Transport Workers Union local 234

George Bannon, Business Agent, TWU Local 234 Jeffrey Brooks, Political Director TWU Local 234

Mr. Bannon stated that on March 15, 2021, the TWU voted to ratify the new terms of the contract. They believe that it is a very fair contract and the members are very satisfied.

LW stated her concern about the significance to the approval of the side letter. She asked for clarification about the negotiation over the job security language within the contract.

CAO replied that there is a *genuine* disagreement between the Administration and the Union in reference to the interpretation of the law surrounding this issue. Therefore, it is in the best interest of both parties to have an independent third (neutral) party to clarify and resolve the differences of opinions.

Mr. Bannon stated that the Union originally thought they had an agreement with the Township. However, this *item* was not part of their agreement. Therefore, a third party may intervene. However, he would prefer resolving this issue without the involvement of the Labor Relations Board.

Mr. Brooks stated that this contract disagreement is a contractual matter not a legal matter. CAO Rongione pointed out that Mr. Brooks provided a short summary of the disagreement between the Township and the Union. The Township believes it is an *inherent managerial prerogative* and the Union believes it is a *contractual* matter.

Solicitor Kilkenny asked that Mr. Bannon and Mr. Brooks clarify their positions on moving forward with the action being presented tonight. Mr. Brooks stated that the unfair labor practice should be removed.

RG expressed that the disagreement between both the Union and the Township appears to be an issue that should be separated from voting in the MOU and side letter.

MS stated that the MOU and the side letter should be voted upon collectively, not separately.

HT called the *Question*.

Motion to approve to approve Memorandum of Understanding and side letter. RG/MS Moved and seconded. A roll call vote was taken. Ten in favor, one opposed (LF). The Motion is approved.

Pat Scott gave a brief on Ordinance No. 3098.

DPB asked if this affects any requirement that must be approved in advanced by Council. Mr. Scott responded that this relates to signature authority for the two bond issues that were approved in November. Solicitor Kilkenny clarified that any refinancing or bond issuance in the future will be presented to Council in advance.

Motion to introduce and advertise: RG/MS Moved and seconded. A roll call vote was taken. Nine in favor. Two opposed (LF, TW). Motion to introduce and advertise Ordinance No. 3098 is approved.

Resolution No. 18-21, a Resolution authorizing application to the Keystone Communities Program through the Pennsylvania Department of Community and Economic Development (DCED) for the Façade Improvement Project

Solicitor Kilkenny gave a brief on Resolution No. 18-21

RG asked for confirmation from the Administration that the Township will raise fifty thousand (\$50,000.00) in funds and match an additional fifty thousand (\$50,000.00) in funds. CAO Rongione reconfirmed.

DPB asked for further details pertaining to the improvements to the facades. The CAO responded that the purpose is to streamline signage and improve the curb appeal. Initially, the Administration spoke with Mr. Galante about implementing a lighting project to improve the appearances of the businesses. However, Mr. Galante suggested pursuing a grant that would improve the quality of the facades. The Administration agreed to implement this grant before initiating the Lighting Project. DPB asked if the owners of the buildings were contributing funds. The CAO stated that the business owners are supportive of this initiative. At this time, he does not believe they are contributing funds. However, he is hopeful that this initiative will inspire the owners to continue with improvements to their businesses, independently.

Motion to approve: MS/SS Moved and seconded. Nine in favor, two opposed (LF, DPB) Resolution No. 18-21 is approved.

Resolution No. 19-21, a Resolution authorizing application to the Community Project Funding through the department of Housing and Urban Development (HUD) for the Economic Development Initiative

Solicitor Kilkenny gave a brief on Resolution No. 19-21

RG asked if there are any matching requirements for these type of grants. The CAO stated that it is a newly revived Federal Program and does not believe there are any matching requirements.

SS suggested adding a *Party Hall* to the Welcome Center for the residents to rent for events. CAO Rongione responded that the inclusion of amenities is dependent upon the funds the Township receives from the County and the State.

DPB asked what the cost would be for the installation of a green roof. Mr. Galante responded that the estimated cost is nine hundred and seventy-five thousand dollars (\$975,000.00), with the assumption of fifty dollars a square

foot.

MS stated that he supports upgrading the Welcome Center for the improvement of the aesthetics, the value and the use of this building.

Mayor Keffer stated that they are working hard to create a future that outlasts the current population.

TW stated that his concern that this will create a debt that would outlast us.

Motion to approve: RG/MB Moved and seconded. Eight in favor, three opposed (LF, DPB, TW) The Motion is approved.

MB inquired about the length of time it takes before the funds are dispersed. Mr. Galante responded that the timeframe is normally around 8-10 months.

BB asked for the value of this Grant for Resolution No. 20-21. Mr. Galante stated that for this particular Grant is worth two hundred and fifty thousand dollars (\$250,000.00). BB stated that the original proposal for funds was two hundred and fifty thousand dollars for each park. Therefore, he wanted clarification that this amount is still valid. Mr. Galante responded that this Grant amount covers Observatory Hill *only*. There will be a separate application for funding of Chapman Park.

RG asked Mr. Galante if he agrees with this Resolution.

DPB asked Mr. Galante if I & I (inflow and infiltration) is a requirement. Mr. Galante responded that it is required, as part of the capacity management plan. DPB asked Mr. Galante who would be responsible for the cost of the I & I. He responded that it would be the applicant. In this case, Aronimink School.

RG asked for clarification of *Exhibit A* within Resolution No. 15-21. CAO responded that he is referring to the former version.

Motion to approve: RG/SS Moved and seconded. Eleven in favor. Resolution No. 15-21 is approved.

Resolution No. 21-21, a Resolution to install a 4-way stop sign at the intersection of Chapman and Powelton Avenues **PER POLICE APPROVAL**

This Resolution will be voted on at the April 21, 2021 Council Meeting.

HT expressed his gratitude for the assistance of LW with the traffic issue in his District. He further explained the importance of the assistance from Council-At-Large on behalf of a specific District.

LW stated that she has fallen short of residents signing the petition for the 4-way stop sign. Therefore, she was unable to list Resolution No. 21-21 on this Agenda. CAO Rongione responded that the petition is important, but not an official mechanism to adjust traffic patterns. LW reiterated that she explained to the residents that the petition is the first step of the process before our Community Police Officer determines the feasibility to install the stop sign at this location.

Introduction of Ordinance No. 3095, an Ordinance of Upper Darby Township, Delaware County, Pennsylvania, establishing and implementing a program to charge user fees for the deployment of public safety services rendered by the Fire Department of Upper Darby Township for delivery of fire and rescue services, personnel, supplies and equipment to the scene of motor vehicle accidents and other incidents on the highways; repealing all inconsistent Ordinances or parts thereof; providing a severability clause and an effective date

Solicitor Richardson gave a brief on Ordinance No. 3095

BB requested that CAO Rongione respond to the public comment pertaining to residents and non-residents. The CAO clarified that it is not permissible to discriminate between a resident and a non-resident when imposing this fee. Furthermore, this is outside the general purview for fire services. Therefore, this fee will offset the cost and generate revenue.

BB stated that he and the Public Safety Committee met with Chief Sawyer and Solicitor Richardson about this Ordinance. BB stated that there is a fee schedule listed in the Ordinance, but the collection agency is not included. He asked Solicitor Richardson if the collection agency should be included. Solicitor Richardson responded that it was not necessary.

MB asked for clarification pertaining to the user fee. The CAO confirmed that we charge the insurance company the user fee.

TW asked for clarification of the meaning of "other incidents", as it appears to be something other than a vehicle accident. Solicitor Richardson stated that it is limited to vehicles and the highway. TW interprets this language as being broad, not limited.

MS stated that other municipalities have adopted this and that it is a standardized fee structure within insurance companies.

LF asked for confirmation that this is included in everyone's insurance policies. BB confirmed that it is included within the insurance companies' policies.

DPB asked if we have chosen a collection agency. The CAO responded that it has not be determined.

TW expressed his concern that our residents would be penalized if their insurance companies refuses to pay the fees. Solicitor Richardson responded that she would amend the Ordinance by stating that the owner of the vehicle would not be financially responsible if there is an issue with the policy or the insurance company.

LW asked that the Solicitor confirm the amendment to Ordinance No. 3095. Solicitor Richardson stated that she would add that if the vehicle owner does not have insurance coverage or their insurance company refuses to pay, then the Township would not seek reimbursement from that individual.

Motion to introduce and advertise: SS/HT Moved and seconded. A role call vote was taken. Ten in favor, one opposed (LF). The Motion is approved.

Solicitor Richardson gave a brief on Ordinance No. 3097

RG asked that we impose limitations to the size and location of the chicken coops. Solicitor Richardson suggested that the Committee meet with the Animal Wardens or the Director of L&I for guidance.






