MW referenced the shooting of Montgomery County Deputy Foster who was shot at the Philadelphia fireworks. Solicitor Kilkenny, who is the Montgomery County Sheriff thanked MW for her concern and stated that Deputy Foster was doing well.

#### **Old Business**

HT stated that at the last meeting, LW mentioned a court date on June 22, 2022 and he was not aware that Council was going through any litigation. He has concerns that Solicitor Boggs would be going outside of his scope of the engagement letter. He stated that Mr. Boggs' last correspondence was that he was communicating with Council President Burke and he was supposed to forward the information to everyone. HT, and 4 other Council members, have received no information in the last 60-70 days. He asked how litigation was taken without a public vote and wanted to know who is representing the Council.

Council Vice-President Wentz stated that HT was referring to the fact that Council had made a Motion that the CAO had forfeited his position, and the litigation was in reference to going to the Courts to have them make an injunction on that ruling. It got postponed from June 22 and there will be a phone call conference scheduled for

July 7, 2022.

MW clarified that a Motion was made for the CAO to forfeit his office which the Council was present for. As Mr. Rongione refused to abide by the Motion, it is in front of a Common Pleas Judge. She added that the Solicitor Kilkenny has stated several times that the Mayor's position is that he is going to remain until that litigation is determined. MW stated that HT was aware of the litigation, as it has been said at multiple meetings that there was litigation.

#### **New Business**

AH stated that he had a comment regarding the previous conversation. He stated that the Council is facing a court date for litigation that the Council did not approve in a public meeting. If Council is filing a Court action to compel the Administration to comply with an action, and he believes that this is not legitimate. Council, as a body, is supposed to vote in a public meeting on litigation. He added that never occurred.

Council President Burke stated that it is going to Court and when the hearing comes through, the reports will be given.

AH asked who authorized the Solicitor and who is paying for the Solicitor to take this Court action, as it was not authorized in a public meeting. He asked Solicitor Kilkenny if it was correct that this would have needed to

be held at a public meeting.

Solicitor Kilkenny stated that he recused himself from this matter and that normally, the Mayor initiates litigation, per the Home Rule Charter, on anything where the Township is a party. He stated that he could not speak to exactly what would be the proper procedure for that and they should speak to Solicitor Boggs to ask whether or not a public vote would be required.

AH asked if anyone communicated and/or director Solicitor Boggs to take this Court action.

Council President Burke asked if Council was aware of everything regarding lawsuits that come before Solicitors Kilkenny and Richardson. He also asked if there had been a vote.

AH replied that a private person filed a lawsuit against Council and that does not require a public vote. He

added that a public vote should be on the record for litigation.

Council President Burke added that everyone has Solicitor Boggs' phone number and email address.

A RESOLUTION OF UPPER DARBY TOWNSHIP TO ENTER INTO AN BETWEEN COOPERATION AGREEMENT THE INTERMUNICIPAL COUNTY OF DELAWARE, THE CITY OF CHESTER, AND THE BOROUGH OF DARBY REGARDING THE 2022 BYRNE JUSTICE ASSISTANCE GRANT AWARD; REPEALING ALL INCONSISTENT **PROGRAM** (JAG) THEREOF; PROVIDING A SEVERABILITY **PARTS** RESOLUTIONS OR CLAUSE; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, this Agreement is made and entered into and between the County of Delaware, acting by and through its governing body, the Delaware County Council ("County"), the City of Chester, Borough of Darby (collectively the "municipalities"), and Township of Upper Darby, acting by and through their respective governing bodies; and,

WHEREAS, this Agreement is made under the authority of the Home Rule Charter of Delaware County, the Home Rule Charter of Upper Darby Township, the Pennsylvania Third Class City Code, and the Pennsylvania Borough Code, as applicable to each municipality; and,

WHEREAS, each governing body in performing governmental functions or in paying for the performance of governmental functions hereunder, shall make that performance or those payments from current revenues legally available to that party; and,

WHEREAS, each governing body finds that the performance of this agreement is in the best interest of each party, that the undertaking will benefit the public, and, that the division of costs fairly compensates the performing party for the services or functions under this agreement, and,

WHEREAS, the County agrees to be the recipient of funding in the amount of \$107,069.00 from the United States Department of Justice from the Edward Byrne Memorial Justice Assistance Grant ("JAG") for fiscal year 2022; and,

WHEREAS, the County is ineligible for direct JAG funding in FY 2022, for JAG purposes the County remains a partner with the Municipalities receiving JAG funding, and must be a signatory on the Memorandum of Understanding ("MOU") required of disparate jurisdictions; and,

WHEREAS, the County and each municipality believe it to be in their best interests to reallocate the JAG funds as follows:

Chester City	\$ 54,268
Darby Borough	\$ 20,387
Upper Darby Township	\$ 32,414

NOW THEREFORE, the County and each municipality agree as follows:

**SECTION 1.** The County agrees to pay to each municipality the amount of JAG funds, as stated above.

**SECTION 2.** Each municipality agrees to use the JAG funds allocated to it for the program in accordance with all federal, state and local laws and as described in the JAG application and will utilize those funds during the four-year period following the award of the grant.

**SECTION 3.** Nothing in the performance of this agreement shall impose any liability for claims against the County or any municipality other than claims for which liability may be imposed by the Pennsylvania Political Subdivisions Tort Claims Act.

**SECTION 4.** Each party to this agreement will be responsible for its own actions in providing services under this Agreement and shall not be liable for any civil liability that may arise from the furnishing of the services by the other parties.

**SECTION 5.** The parties to this Agreement do not intend for any third party to obtain any right by virtue of this agreement.

**SECTION 6.** By entering into this Agreement, the parties do not intend any obligations, express or implied, other than those set out herein: further, this Agreement should not create any rights in any party not a signatory hereto.

**SECTION 7. REPEALER.** Any resolutions or parts thereof inconsistent with the provisions of this Resolution are hereby repealed to the extent of the inconsistency.

**SECTION 8. SEVERABILITY.** If any provision of this Resolution is declared by a court of competent jurisdiction to be invalid or unconstitutional, such determination shall have no effect on the remaining provisions of this Resolution.

**SECTION 9. EFFECTIVE IMMEDIATELY.** This Resolution shall become effective immediately following its legal enactment and shall remain in effect hereafter until revised, amended, or revoked by action of the Upper Darby Township Council.

This Agreement is made and entered into as the date stated below by and between the County of Delaware, acting by and through its governing body, the Delaware County Council, hereinafter referred to as "County", and the City of Chester, Borough of Darby, and Township of Upper Darby, acting by and through their respective governing bodies. Witnesseth:

# <u>Upper Darby Township Police</u> 2022 Edward J. Byrne Justice Assistance Grant

# **Program Narrative**

Award: \$32,414.00

Verizon Wireless Internet (Air) Cards......\$15,600.00

The Upper Darby Police Department utilizes a record management system that is accessed by police officers in their vehicles via wireless internet access cards. These cards have allowed police officers to produce incident reports, identify persons engaging in criminal behavior, and efficiently share justice information with other agencies. Naturally, a cost is associated with these cards and it is an expense that the department cannot afford to fund alone. The police department seeks \$15,600.00 which will provide service for a one-year period.

The remaining funds of the 2022 JAG will supplement police overtime as this will provide personnel deployment in key areas. This especially pertains to high crime areas during intervals when criminal activity peaks, such as the summer months. In 2021, the police department answered in excess of 12,000 calls for service from June through August. Using the available funds to supplement manpower would assist us in our efforts to increase public safety during this summer season as well as throughout the year.
