Please note that grass clippings are NOT considered yard waste. Please do not use plastic bags to recycle yard waste or single-stream recycling; instead, place your yard waste in biodegradable paper bags, which are available at local hardware stores, or place the yard waste loosely in trash cans without bags. Yard waste is collected on your regular recycling pick-up day, not on trash pick-up days.

DPB expressed concerns about interference with the UCC.

TW asked about regulating fire pits that cause smoke from burning debris instead of wood. Chief Sawyer stated that propane fire pits are a cleaner burn as are wood logs.

LW thanked Chief Sawyer for meeting with the Public Safety Committee

Solicitor Kilkenny gave a brief on Ordinance No. 3100.

RG asked about the section referring to the Bond and Solicitor Kilkenny stated that he believes that the Bond should indemnify the Township and make sure it protects the Township. He will work with the Administration on this matter.

Fire Chief Derrick Sawyer stated that this Ordinance will be beneficial to the UDFD by regulating fireworks, thereby protecting residents.

Motion to introduce and advertise Ordinance No. 3100: DB/RG A roll call vote was taken. All in favor. Motion to introduce and advertise is approved.

Additional Committee business:

BB stated that the Public Safety Committee met and they are asking that the Township look at the necessary painting around the schools and parks for safety issues when school starts up again. He also requested repaving where necessary.

HT thanked DB, BB, LW and Chief Sawyer for walking through the Chapman neighborhood and addressing concern.

MS requested crosswalks at each park for safety issues.

The Committee will be meeting in the next few weeks to visit another school.

CAO stated that the Mayor has started a "focus zone program" in neighborhoods where pertinent issues will be addressed, such as faded crosswalks, bleached out stop signs. The goal is to have a routine maintenance schedule where such issues can be addressed.

MS asked if there are any rules about putting stop signs where there are crosswalks. The CAO stated that vehicles must yield to pedestrians so perhaps flashing signs would be more beneficial.

RG stated that he has a petition to make a 2-way stop sign into a 4-way stop sign on Lllanfair Road and when he has enough signatures, he will submit it for review.

MB stated that a resident reached out about a lack of lighting on Church Lane. The CAO stated that a request should be submitted to the Mayor's Request line and the Electrical Department will assess the lighting issue

RG asked about an update for Beverly Hill Middle School flashing signs.
