Upper Darby Township allocated their CDBG and CARES Act funding to assist low/mod income individuals and neighborhoods based on the greatest current needs and in accordance with the Priority Needs outlined in the Consolidated Plan.

First Time Homebuyers were provided up to \$6,000. toward their downpayment/closing costs to assist them in purchasing thier first home. This program is one of the townships most successful programs. It also helps the community due to the fact that alot of the homes being purchased were vacant. The amount of the purchase price was increased this year in order for our First Time Home Buyers to keep up with the current competive Real-Estate Market.

Throughout this reporting period Upper Darby has sucessfully assisted low/mod CT/BG residents through the Housing Rehabilitation Program, First Time Home Buyers Downpayment Assistance Program, park and playground improvements in low/mod neighborhoods and providing handicap curb cuts and also providing community assistance through local Non-Profits.

The Township has utilized its CARES Act Funds to selected projects in the community to assist in safety measures and contact prevention to

street and walkway widening for better pedestrain social distancing and provision of vechiles to aid in delivery of meals to Senior Citizens who reduce exposure to COVID-19 and its varients. These projects include, touchless restrooms in Libraries, bike racks for mobility improvments, are unable to leave thier homes.

Cares Act funding was also used to prevent those who lost income as a direct result of the pandemic, from becoming homeless by providing rental, mortgage, or utility assistance payments.

The Township selected projects to promote thier goal of Affordable Housing through Housing Rehabilitation Programs and the First Time Homebuyer down payment assisatance program. Upper Darby Township selected Public Service projects based on the biggest increase in need, the Priority Needs identified in the Consolidated Plan and the Subrecipent's capacity to carry out the projects.

The Township provided funding in the form of a Subreciepient Agreement to the Delaware County Action Agency for Homelesss Assistance.

The Code Enforcement Project was cancelled and the funding was out into other projects, an Action Plan Amendment was completed

Fair Housing and Administrative funds were also used to benefit low/mod income residents and areas. Fair Housing funding was used, in addition to Township funding to assist residents who are experiencing tenant/landlord issues, especial those who are non-English speaking.

The Township applies regularly for Liquid Fuels funding and other State funding to supplement the CDBG grant.

Narrative Information

The Township has allocated CV funding for homeless prevention for those who are at risk of becoming homeless due to loss of income as a result of the COVID-19 pandemic. That project is carried out by the Delaware County Community Action Agency.

Reaching out to homeless persons (especially unsheltered persons) and assessing their individual needs

Upper Darby provides funding to Community Action Agency (CAADC) through Public Services funding which is capped out at 15% to operate the Life Center Homeless Shelter.

The Township no longer recieves ESG funding, it is provided at County level.

Addressing the emergency shelter and transitional housing needs of homeless persons

ESG funding goes to the County, Upper Darby no longer receives ESG funding. We do, however, allocate funding within the 20% Public Services cap for homeless assistance through a Subrecipient Agreement with the Community Action Agency of Delaware County (CAADC).

Upper Darby successfully obtained funding from the State of PA (\$1,050.000.00) and the County (\$1,347,473.00) to renovate an exising building and open a 30 bed Homeless Shelter, Breaking Bread Community Shelter in the 69th Street area where homeless assistance is badly needed. The goal is to move people into permanent housing. In addition to housing, food, legal aid and medical care will also be provided.

Helping low-income individuals and families avoid becoming homeless, especially extremely low-income individuals and families and those who are: likely to become homeless after being discharged from publicly funded institutions and systems of care (such as health care facilities, mental health facilities, foster care and other youth facilities, and corrections programs and institutions); and, receiving assistance from public or private agencies that address housing, health, social services, employment, education, or youth needs

These services are provided at the County level by the CAADC and othe non-profit organizations.

The Welcome Center provides Fair Housing education for the community and also assists with Tenant Landlord disputes, especially for those that are immigrants and/or non-English speaking. Direct Public Services are also provided to both the Multicultural Center and the Domestic Abuse Project to provide assistance and referrals to those who may be at risk of becomming homeless. All Public Services are funded withing the 15% cap.

The Township also provides funding with the Public Services cap to the Community Action Agency of Delaware County for homeless assistance.

Upper Darby township no longer receives ESG funds, it is provided at County level.

Decreased funding is a major obstacle. While the cost of living and housing in general continues to rise, salaries do not. The Global COVID-19 pandemic has contributed to rising costs, in all areas.

The Township continues to fund local non profits within the Public Services cap to assist those with a variety of underserved needs.

The Township has provided funding through the CDBG-CV to meet the needs of those impacted the most by the global pandemic.

Upper Darby no longer receives funding for Homeless Prevention which enabled them to assist many households who were at the risk of becoming homeless, however they did allocate a portion of thier CDBG-CV funding to that goal. We also allocate CDBG funding under the Public Services cap for Homeless Assistance under a Subrecipient Agreement with the CAADC.

Separately, Upper Darby successfully obtained funding from the State (\$1,050,000.00) and the County (\$1,347,473.00) to renovate an existing abandonded building open a new 30 bed homeless shelter called Breaking Bread Community Shelter in the 69th Street area. It is a 30 bed shelter with the goal of moving people into permenant housing, it will also provide food, legal aid and medical care to individuals experiencing homelessness.

Actions taken to reduce lead-based paint hazards. 91.220(k); 91.320(j)

Every property in the Housing Rehabilitation Program that receives more then a \$5,000.00 Grant has a XRF and Risk Assessment completed, by a Certified Lead Inspector/Risk Assessor Contractor.

Remediation is completed as needed which is in almost every home and a post remediation clearance is

completed. Educational information is also provided to all Homeowners.

Upper Darby's First Time Homebuyer Downpayment Assistance Program requires each property pass a visual paint inspection of all painted surfacesis done in accordance with the law by a Certified Inspector.

FTHB clients and Housing Rehabilitation clients are provided with a copy of the EPA pamphlet "Protect Your Famiy From Lead In Your Home."

Community Action Agency (CAADC) has been funded every year within the Public Services cap of 15%. The majority of funds are used to assist those at the homeless shelter.

The community also provides outreach assistance to those in need. Upper Darby no longer receives ESG or Homeless Prevetion funds.

The Township continues to support local businesses to help create local jobs.

Impediment #2 Education

Upper Darby Township participates remotely in the bi-monthly educational seminars presented by the Housing Equality Center. The Township distributed fair housing materials and information about services that are available through their housing rehabilitation and First Time Homebuyer Program. The information obtained at the Housing Equality Center is shared with Township departments in order to educate them in their dealings in the community.

The Township also distributed Fair Housing posters and pamphlets throughout the community, including the public libraries and in all Township buildings, including the Welcome Center.

The CAADC with the public services funding provided for homeless assistance also provided housing counseling, credit counseling and housing placement services.

The Multicultural Center with their public services funding provided education to immigrant residents with English as a second language.

The Welcome Center (new service) is including Fair Housing Training as a part of their ESL classes. They have also become involved in intervening with tenant landllord eviction issues, especially with immigrants who do not speak the language.

Information was provided to all of the landlords in the Township data base regarding Fair Housing issues and tenants

Impediment #2

Lending practices, the Township has built relationships with local lenders through the First Time Homebuyer Program. Many of the local banks also have First Time Homebuyer assistance and special programs to assist lower income households, such as Citizens Bank Home First Program and Bank of America's American Home Grant.

The Township uses their updated CPD Monitoring Manual for all Subrecipient Monitoring. They have a variety of checks and balances internally. The planning process is open, clear and transparent and all residents and stakeholders are invited to participate.

All Public Notices are run in multiple languages. The Township has adopted a Citizen Participation Plan that clearly outlines thier policies and procedures and it is rigorously followed.

All project requests are thoroughly reviewed against the Township's goals and an eligibility/fundability analysis is also done on each one. Each project must meet the Township's objective to assist the low/mod income residents, the underserved, and/or low/mod Cencus Tracts and Block Groups.

Every RFP includes a minority outreach effort, and Section 3 Compliance documents are all included in all contracts.

As mentioned elsewhere, the Township has a very diverse population and it seeks to assist them through the ESL funding and through the Welcome Center Programs funded by the Township.

The Township does not receive ESG funding that would enable them to reduce or end homelessness. That funding is provided at the County level.

Assistance is offered to any local non-profit wishing to submit a request for funding to ensure that they understand the process and are able to meet the required goals.

30-bed shelter for the homeless opens in Upper Darby



UPPER DARBY — A blessing, love, community, an opportunity, and ... about time.

Those were some of the feelings advocates voiced Monday morning at the ribbon cutting for a 30-bed homeless shelter near 69th Street.

The onset of cold weather sped the opening of the Breaking Bread Community Shelter at 107 Long Lane, in what once was a day care center, to bring unhoused people out of the cold and get them on the path to permanent housing.

As officials cut the ribbon on the first floor, construction workers were working upstairs to finish additional space the that will serve the eastern part of Delaware County.

"This is really about moving people into housing. We want to work towards a

day when we don't need these shelters anymore," said Stephanie Sena, the driving force behind the shelter. "People, every one of us, deserve a safe, secure place to sleep at night, that is what our goal is."

Sena, a resident of Middletown, is the Anti-Poverty Fellow at Villanova University where she has taught for nearly 20 years, and is the founder and executive director of the Student-Run Emergency Housing Unit of Philadelphia, a nonprofit community and rehousing center, operating since 2011.

about community, it's about people coming together," said Sena. "This was a herculean effort. It was many years in the making."

Sena said the shelter will be one of a very few that accepts people with pets. She said 25 percent of all people experiencing homelessness have their pets with them.

"When they can't bring their pets into a shelter what often happens is they refuse to access shelter or they have to give the pet up to an animal shelter where there is a high rate of animal euthanasia," she said.

She noted the new shelter will serve couples and will also be wheelchair accessible, which is also unusual.

Sena said homeless shelters are the gateway in the U.S. to housing and if barriers are in place, it keeps the homeless from finding housing.

In addition to shelter, the center will provide food, legal aid and medical care to individuals experiencing homelessness, Sena said.

"This is what we have been asking for. We've been saying we need something on 69th Street. We're getting there, step by step," said Tina Hamilton of Recovery Without Barriers, an outreach group that has been active on 69th Street for the past few years.

For William Crossan, who grew up nearby on Kingston Road, the shelter is an opportunity to regain a footing after years on the streets.

"To have an opportunity to start living life, it's better ... than just existing, because that's all I did on the street," said Crossan, 56, who has been homeless and is hoping to be a resident at the new shelter. He he said had a couple downfalls when he was younger, which put him there.

"I've been trying to stay above water and just haven't had the right opportunity," he said.

He said in addition to the opportunity, is the follow up from case managers to help those on the street who aren't altogether suited to be fiscally stable or make the right decision without assistance as a result of drugs or being on the street.

"Mine was the street mentality, which is totaling different from the normal mentality," Cressan said.


During the festivities, state Rep. Gina Curry (D-164th) and state Sen. Tim Kearney (D-26th) presented Sena with a state check for \$750,000, which was in addition to an earlier \$300,000 state grant through Kearney's office.

The Delaware County Office of Housing and Community Development supplied \$1,045,173 for acquisition and rehabilitation of the building and county Human Services supplied \$302,300 for initial operations of the shelter

Sena said housing in the county is in such a critical state that work on the facility was still taking place. The first floor is finished but construction crews are busy on the second and third floors of the building.

"We have such an emergency that we could not wait to be opened. It's freezing right now and there are people sleeping outside and in their cars and the alleyways," she said.

The new facility includes an elevator and showers, which Sena called vital for residents' well-being.

The second phase will finish the upper floors.

Sena credited Mayor Barbarann Keffer for seeing the need and allowing Breaking Bread Community Shelter to open when other communities are pushing out shelters.

"Right now mayors are shutting down homeless shelters and I see that every day," Sena said.

Curry said the shelter will have a great impact in the community.

"For all the warriors in here who fight for housing, and food insecurity and all the

things people go through, we know there is hope on the other side," Curry said. "Thank you for putting your all into this."

"It's a great day for Upper Darby. It's been a need that has been present here for so long. The people who put this together did it in such a loving and thoughtful way. It's a great thing," said Kearney. "It's going to clean up a lot of the issues in 69th street and it's going to help a lot of folks. It's not just a place to stay, it's a place to start recovery."

"The need to offer a shelter to residents in the eastern section of our county is great, especially during the harsh, cold winter months," said Delaware County Council Chair Dr. Monica Taylor. "Thank you to Stephanie Sena and her team along with members of the Delaware County Office of Housing and Community Development, Department of Human Services, Upper Darby Township, and state legislators for working together to bring the Breaking Bread Community Shelter to Upper Darby. It was a much needed service and we are grateful for your dedication and compassion."
