Notice is hereby given that Upper Darby Township (the Township) is currently preparing its Five-Year Consolidated Plan for the period of 2026-2030 (Program Year 52-Program Year 56). The Township will apply for Program Year 52 Community Development Block Grant (CDBG), Home Investment Partnerships (HOME), and Emergency Solutions Grant (ESG) funds from the U.S. Department of Housing and Urban Development (HUD). In accordance with the Final Rule for consolidation of the CDBG, HOME, and ESG Programs, 24 CFR Part 91, et. al., the Township will prepare a Consolidated Plan and an Annual Action Plan, which will be submitted to HUD on or before Saturday, August 15, 2026.

Notice is also given that the Township will hold a public hearing on Monday, March 16, 2026 at 6:00 PM. The purpose of this hearing is to obtain the views and comments of individuals and organizations relative to housing and community development needs that may be addressed by CDBG, HOME, and ESG funds during the next five years. The hearing will be held in the Upper Darby Township Municipal Building, 100 Garrett Road, Upper Darby PA, 19082.

All interested residents, public agencies, and other interested parties are invited to attend the public hearing and present comments concerning housing and community development needs. Written comments can also be submitted in the following ways by Tuesday, March 31, 2026:

The Township will consider comments on the proposed plans prior to adoption by the Upper Darby Township Council in July, 2026.
