Overview: Key Objectives of This Funding

The Coronavirus State and Local Fiscal Recovery Funds deliver \$350 billion for state, local, territorial, and Tribal governments to respond to the COVID-19 emergency and lead a strong, resilient, and equitable recovery.

Key objectives of this funding:

- Fight the pandemic and support families and businesses struggling with its public health and economic impacts
- Maintain vital public services, even amid declines in revenue resulting from the crisis
- Build a strong, resilient, and equitable recovery by making investments that support longterm growth and opportunity

Purpose: The sewer upgrades will address longstanding deficiencies in the system that has disproportionately impacted the economically disadvantaged areas of the 4003.01 Census Tract. These investments will save money on repairs, improve the day-to-day operations and experience of our residents, and make Upper Darby a more attractive destination for homeowners and businesses going forward.

Program: Investments in Police & Fire
Amount: \$5,500,000
Managing Departments: Police, Fire, and Community & Economic Development
Existing or New Project: Existing and New
Purpose: During the pandemic, our Police and Fire were on the frontlines. Many, if not most, of our current fire apparatus does not meet even the reserve standard and badly needs to be upgraded. In order to maintain Upper Darby as a healthy and safe community, our police department needs these resources to access proven data-driven strategies for gun violence prevention.

Gun Violence Prevention

Program: Gun Violence Prevention Initiative

Description: Develop a comprehensive strategy using experts in the field and already proven data-driven methods and policies to ensure Upper Darby remains a healthy and safe community.

Amount: \$1,000,000

Managing Department: Police and Community & Economic Development Existing or New Project: New

Highlights:

- Build meaningful community partnerships to address root causes and social determinants of gun violence through the Department of Community & Economic Development
- Re-start the PAL (police athletic league) program at the Community Center
- Host a gun buyback program as one small part of a comprehensive strategy

Grants Awarded (\$2,000,000)

- RACP 1 \$1 million (1:1 match)
- RACP 2- \$1 million (1:1 match)

Federal Appropriations (\$1,000,000)

 Community Project Funding - Green Roof - \$1 million (match eligible)

Active Grant Applications (\$4,000,000)

- Local Share Account energy efficiency \$1 million (no match)
- RACP 3- \$3 million (1:1 match)

All grants were voted on by Council and unanimously approved through resolution


By understanding and leveraging grant opportunities, we could achieve **\$11,000,000** in investment for a \$4,000,000 expense to the taxpayer.

Upper Darby Community Center - Bids

We received submissions from roughly 15+ unique contractors across the areas of General, Electrical, Plumbing, and Mechanical and we are currently in the process of vetting these bids for compliance with our <u>Responsible Contractor Ordinance</u>.

- General Contractor bids (6) Range from \$7 to 10 million
- Plumbing Contractor bids (9) Range from \$300,000 to \$1.3 million
- Electrical Contractor bids (3) Range from \$750,000 to \$1.1 million
- Mechanical Contractor bids (6) Range from \$750,000 to \$1 million

Overall Bid Range - \$9 to \$13 million

Purpose: Add and expand greenspace in economically disadvantaged and currently underserved areas of the Township. Utilizing the currently underway Open Space and Parks Master Plan, we will do system wide park improvements as well as targeted acquisitions.

In a Qualified Census Tract: The projects will be offered across the township but will include directed efforts to expand open space within Qualified Census Tracts.
